1. VIRTUAL MEETING

- (a) We, CapitaLand Malaysia REIT Management Sdn. Bhd. ("Manager"), as Manager to CLMT, wish to inform that the upcoming Unitholders' Meeting of CLMT will be conducted on a virtual basis through live streaming via remote participation and electronic voting ("RPEV") facilities from the Broadcast Venue, details as set out above.

2. ENTITLEMENT TO PARTICIPATE AND VOTE REMOTELY

- (a) Only a depositor whose name appears on the Register of Depositors as at 16 February 2023 shall be entitled to participate and vote at the Unitholders' Meeting or appoint proxies to participate and/or vote on his/her behalf.
- (b) If you are unable to participate at the Unitholders' Meeting, you may also appoint the chairman of the meeting ("Chairman") as your proxy and indicate the voting instructions in the Proxy Form.

3. <u>VOTING PROCEDURE</u>

- (a) The voting on the resolutions at the Unitholders' Meeting will be conducted by poll. The Manager has appointed Boardroom Share Registrars Sdn. Bhd. ("Boardroom" or "Poll Administrator") as poll administrator to conduct the poll by way of electronic voting (e-voting) and Quantegic Services Sdn. Bhd. as the scrutineer ("Scrutineer") to verify the poll results.
- (b) You and your proxies are required to use one (1) of the following methods to vote remotely:
 - i. Launch Lumi Unitholders' Meeting by scanning the QR code given to you in the email along with your remote participation User ID and Password; or
